

Market Commentary

Generali Equity Concept Thematic recorded a performance of +1.13% in February 2024. The JCI recorded a performance of +1.50% in February 2024, rising from around 7210 to 7310. The positive performance of the stock market could be attributed to the positive sentiment following the conclusion of the Round One Presidential Election. The results of the election quick count indicated a continuation of the current administration policies, which might have reduced potential market uncertainties and helped boost the economy in the following months. The four biggest bank stocks (BBCA, BMRI, BBRI, and BBNI) experienced positive growth due to the post-election effect and solid FY23 results. In addition, Indonesia's fundamentals remained strong to support its economy, with its stable inflation rate (2.75% in Feb 2024 vs 2.57% in Jan 2024), high manufacturing PMI (52.7 in Feb 2024 vs 52.9 in Jan 2024), and positive annual GDP growth (4Q23 5.04% vs 3Q23 4.94%). Nevertheless, the following large-cap stocks represented the stock market movement in January (e.g., BBCA +3.40%, BBRI +7.46%, BREN +22.22%, BMRI +5.26%, AMMN +12.96%, TLKM +1.01%, BBNI +4.35, ASII +1.95%, AMRT +3.77%, BRIS +6.01%).
