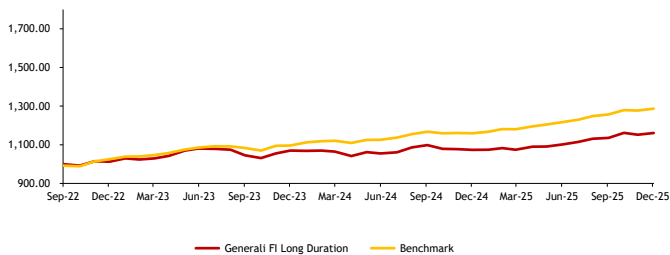

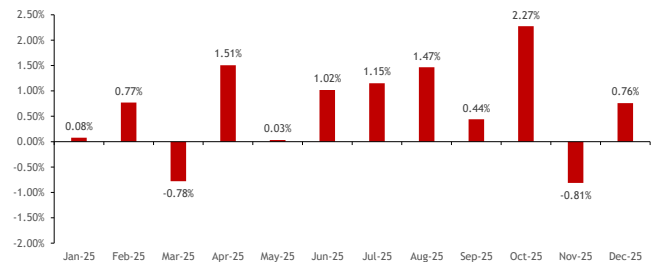

Market Commentary

Generali Fixed Income Long Duration recorded a performance of 0.76% in December 2025. In December 2025, the Indonesian bond market continued to deliver a constructive performance, supported by stable domestic macroeconomic conditions and a more stable global monetary policy environment. Bank Indonesia maintained the BI-Rate at 4.75%, providing policy certainty and helping preserve Rupiah stability. The positive performance of the Indonesia Composite Bond Index (ICBI) reflected sustained investor confidence, underpinned by adequate market liquidity and continued foreign inflows. With inflation remaining well contained and domestic demand staying resilient, rupiah-denominated bonds—particularly in the short- to medium-tenor segment—remained an attractive option toward the end of 2025.
