



Market Commentary

DPLK Generali Equity Bravo recorded a performance of 2.32% in December 2025. In December 2025, the Indonesian equity market continued to post moderate gains, supported by an accommodative monetary stance and resilient domestic macroeconomic conditions. Bank Indonesia maintained the BI-Rate at 4.75%, providing policy certainty amid ongoing global uncertainties. The Rupiah remained relatively stable, while controlled inflation helped sustain investor confidence. Domestic economic activity stayed solid, supported by year-end consumption and continued expansion in the manufacturing sector. Foreign investors maintained a net buying position, with preference toward large-capitalization stocks in the consumer, banking, and infrastructure sectors. Overall, December marked a constructive year-end for the Indonesian stock market, reflecting economic resilience and a solid foundation heading into 2026.
