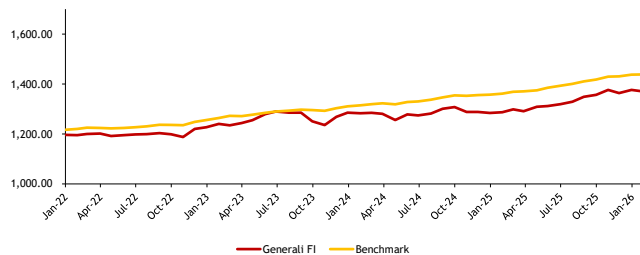

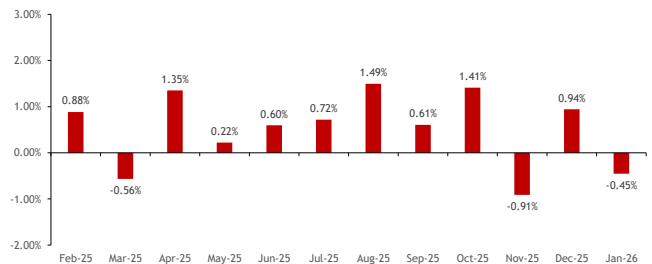

### Market Commentary

Generali Fixed Income recorded a performance of -0.45% in January 2026. In January 2026, Indonesia's macro backdrop has shifted into a phase of orderly consolidation following the monetary easing in late 2025. Bank Indonesia's decision to keep the BI-Rate at 4.75%, alongside the Federal Reserve's completion of its quantitative tightening cycle, continues to support a constructive fixed income environment. Inflation remains well anchored within target, while momentum from Q3 2025 GDP growth of 5.04% underpins macro stability. In the bond market, ample liquidity from year-end maturities and sustained foreign inflows has kept yields compressed, particularly in the short- to intermediate-tenor segment, allowing the Indonesia Composite Bond Index (ICBI) to extend its upward trend. Overall, the policy alignment between BI and the Fed supports lower funding costs and steady capital inflows at the start of 2026.
