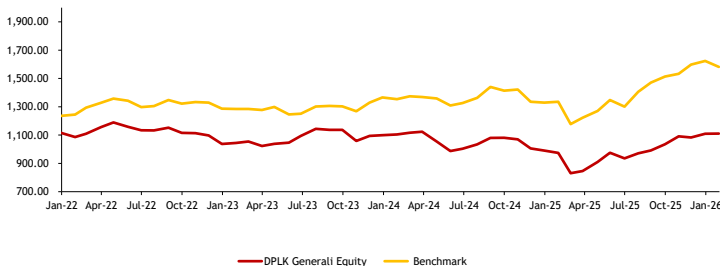

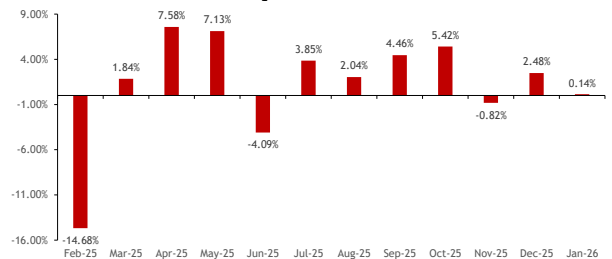

### Market Commentary

DPLK Generali Equity recorded a performance of 0.14% in January 2026. In January 2026, the Indonesian equity market showcased a tale of two halves, characterized by a historic rally to an all-time high of 9,134.70 followed by a sharp period of consolidation. The month began with robust momentum fueled by a steady BI-Rate of 4.75%, a healthy manufacturing PMI of 52.6, and the favorable global shift following the end of the Fed's tightening cycle. However, the market faced late-month turbulence as concerns over trading transparency and index rebalancing triggered profit-taking in the financial and technology sectors, briefly overshadowing the resilient performance of consumer and industrial stocks. Despite this volatility, the fundamental outlook remains positive, supported by low inflation and ample liquidity, suggesting that the recent correction serves as a healthy normalization within a broader long-term growth trend.
