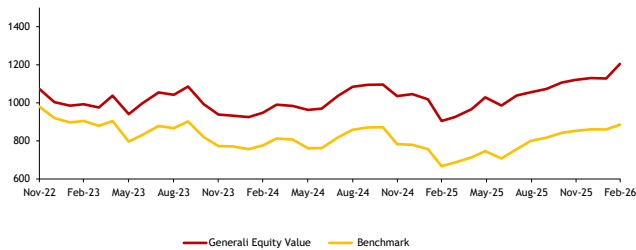

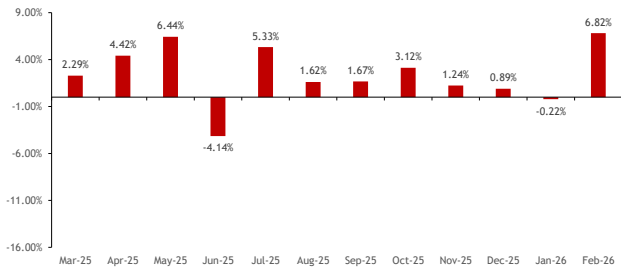

Market Commentary

Generali Equity Value recorded a performance of 6.82% in February 2026. Indonesian stock market in February 2026 entered a strategic transition phase characterized by a shift in investor focus from early-year euphoria toward actual corporate performance through the release of 2025 annual financial reports. Market dynamics this month were marked by selective buying of blue-chip stocks in the banking and consumer sectors—driven by high dividend expectations—which acted as a primary buffer against continued consolidation in the technology sector. The stability of the BI-Rate at 4.75% and well-controlled domestic inflation continued to maintain the attractiveness of risk assets, ensuring that the remaining profit-taking pressure from January was viewed as a healthy accumulation opportunity for institutional investors. With the return of foreign capital inflows bolstered by consistently solid macroeconomic fundamentals, the market demonstrated strong resilience, confirming that this short-term volatility is a constructive normalization phase to strengthen the foundation for long-term growth trends.
