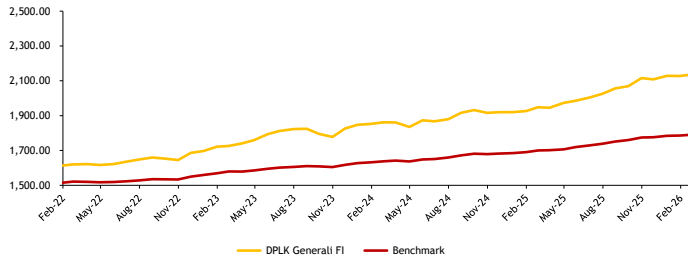

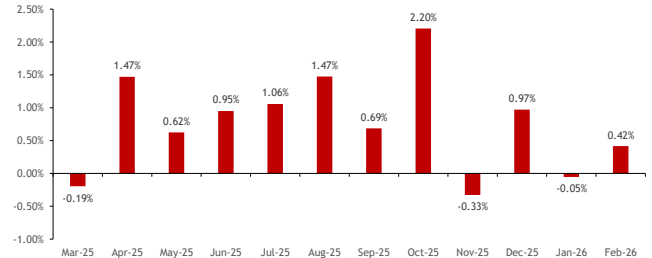

Market Commentary

DPLK Generali Fixed Income recorded a performance of 0.42% in February 2026. In February 2026, Indonesia's macroeconomic landscape remained in a well-ordered consolidation phase following the monetary easing cycle of late 2025. Bank Indonesia's decision to maintain the BI-Rate at 4.75%, coupled with the conclusion of the Federal Reserve's quantitative tightening, continues to foster a highly conducive environment for the fixed-income market. Inflation remains well-anchored within the target range, while stable economic growth momentum reinforces overall macro stability. Within the bond market, ample liquidity from reinvestment activities and sustained foreign inflows have kept yields suppressed, particularly across the short-to-medium tenors, allowing the Indonesia Composite Bond Index (ICBI) to maintain its upward trajectory. Overall, the alignment between Bank Indonesia and Fed policies continues to support lower funding costs and stable capital flows through February 2026.
