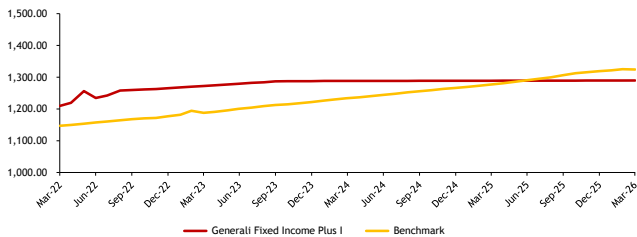

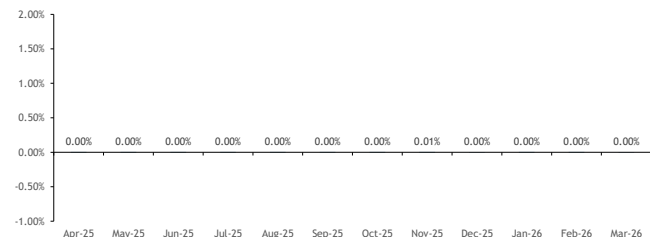

## Market Commentary

Generali Fixed Income Plus I recorded a performance of 0.00% in March 2026. In March 2026, Indonesia's overall economy stayed in a steady consolidation phase after the late-2025 monetary easing. Bank Indonesia kept the BI-Rate at 4.75%, and the Federal Reserve ended quantitative tightening, supporting fixed-income markets. Inflation held within target, backed by consistent economic growth and solid macro stability. In the bond market, strong liquidity from reinvestments and steady foreign inflows suppressed yields, especially in short-to-medium tenors, driving the Indonesia Composite Bond Index (ICBI) higher. Aligned policies from Bank Indonesia and the Fed ensured low funding costs and reliable capital flows through March 2026.
