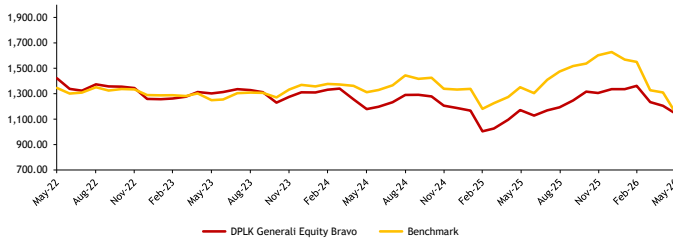

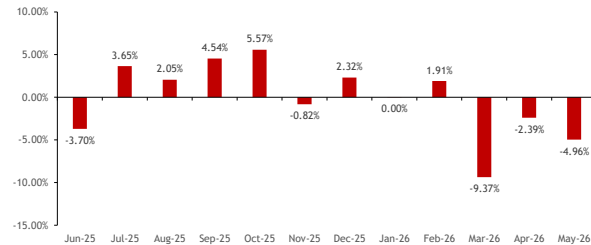

Market Commentary

DPLK Generali Equity Bravo recorded a performance of -4.96% in May 2026. Indonesia's stock market in May 2026 suffered its deepest monthly loss since 2012, with the IHSG closing at 6,127.38, down 11.92% month-on-month and 29.14% year-to-date. Two forces hit simultaneously: the MSCI index rebalancing, which forced global investors to exit several major Indonesian stocks, and continued rupiah weakness that eroded the appeal of domestic assets for foreign investors. The index recorded an unbroken eight-session losing streak between May 8 and 21, underscoring the absence of meaningful buying support. Consumer stocks and names that retained their place in global indices offered selective shelter. Analysts noted that the selloff reflects global liquidity dynamics more than any deterioration in Indonesia's economic fundamentals—leaving the door open for long-term investors to consider accumulation as valuations reach historically depressed levels.
